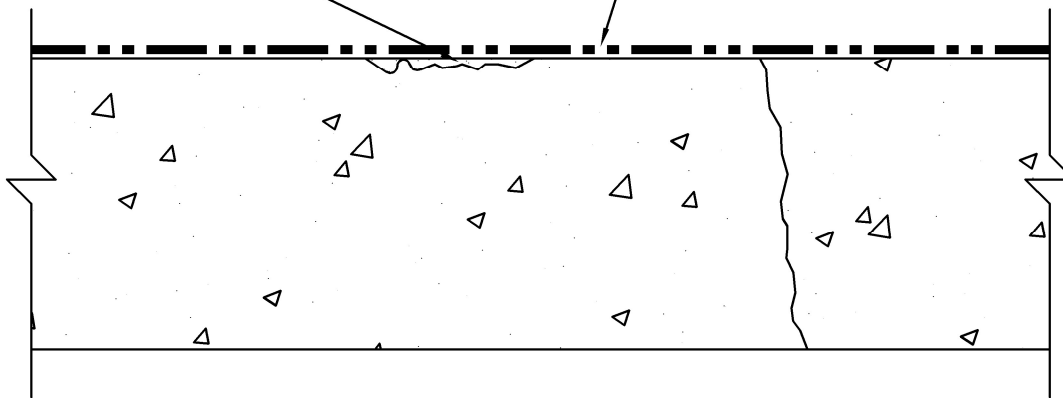

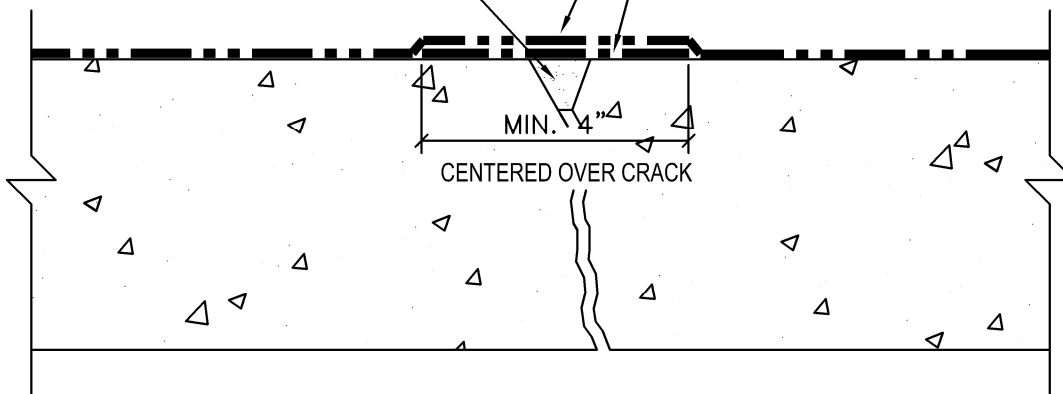


ROUGH CONCRETE AND NON-MOVING SHRINKAGE CRACKS

2. APPLICATION OF APPROPRIATE SIKALASTIC RAPID PRIMER MUST PRECEDE APPLICATION OF SIKALASTIC RAPID RESINS.
3. ALL SIKALASTIC RAPID FLEECE, INCLUDING OVERLAPS, MUST BE SET IN AND COVERED OVER WITH SIKALASTIC RAPID RESIN.
